Minutes of the Annual meeting of Templeton Community Council

Held on 16th May 2024

- 1. Election of Chairman. Cllr Williams was nominated for the position, and accepted the nomination. She was unanimously elected by those present, duly signed her declaration of office, and took the Chair.
- 2. Retiring Chairman's address. No address was made because the retiring Chairman was absent from the meeting
- 3. To accept apologies for absence. Cllr Jason Jennings.
- 4. Election of Vice-Chairman. Cllr Ashbridge was proposed for the role, which she accepted, and she was unanimously elected to the position. She duly signed her declaration of office.
- 5. Annual accounts for 2023-24. These were reviewed, together with the previously circulated report of the Internal Auditor. The Council governance statements in the Annual Return were then considered and it was agreed the Council was in compliance. The RFO and Chairman therefore signed the Annual Return. A recommendation from the Internal Auditor was for the Council to become the sole Trustee for TCHT. This was discussed at length and the Council agreed that they were in favour of this in principle if it could be done. The matter would be taken to TCHT.
- 6. Appointment of Council Internal Auditor for 2024-2025. It was agreed to appoint the same internal auditor again. It was noted that the Council had sought comparative quotes from various local internal auditors in spring 2024 to confirm that they were getting best value for the Council in this matter.
